Here are the answers to the most vital reimbursement questions many Illinois have. Where is My State of Illinois Illinois The Illinois Department of Revenue must process and approve the state's annual tax returns before refunds are issued by the Illinois Comptroller's Office. How quickly Illinois taxpayers get their refunds depends on how they chose to receive the money. In Illinois, taxpayers have two refund options: Direct deposit: Those who file their returns electronically can have their refund deposited directly into their checking or savings account. This is the quickest option, taking up to two business days after the refund is issued. Paper check: Refunds will be mailed to those who choose to receive a paper check. This method is much slower and can take up to 10 business days after the refund is issued. Whether returns are filed electronically or in paper form, Illinois taxpayers should expect a slight delay in receiving their refunds compared to previous years as the state's revenue department takes additional steps to avoid potential theft or fraud. How Can I Check on the Status of My Illinois State Refund? Taxpayers can check on the status of their refunds using simple tools offered by the Illinois Department of Revenue and the Illinois Comptroller's Office. To find out whether the Illinois Department of Revenue has approved a refund, taxpayers can use the eÁÁÁWhere's My Refund? ÁÁÁ feature on the agency's My Tax Illinois website. Those who have already had their refund approved by the state revenue department can check with the Illinois Comptroller's Office for more specific information, including the status of the disbursement. "Providing the exact whole dollar amount is essential to receiving the correct response," the agency says. After entering your information, the tool will provide you with one of three statuses: Return received.Refund approved.Refund sent. The tool is updated once a day, the IRS says, and gives taxpayers a projected refund issuance date as soon as it's approved. The service can provide status details 24 hours after e-filing a return. If it's been more than 21 days since a tax return was e-filed or more than six weeks since mailing a return, taxpayers can call a tax help hotline to talk to a representative. If the IRS needs more information to process the return, you'll be contacted by mail. According to the IRS, one out of 10 refunds is issued in less than 21 days. As of the week ending April 1, the IRS has sent out more than 63 million refunds worth over \$204 billion. As of April 15, the agency has issued more than 78 million refunds worth over \$242 billion in total. The average refund is \$3,226, according to the IRS. This year, the deadline was later than usual -- April 18. Most years, Tax Day falls on April 15.
